b. d. The **TRUSTEES** shall carry out their duties as economically and carefully as much as possible. However, the **TRUSTEES** shall not be liable for any loss, damage or other detriment caused to the **TRUST** in respect of their actions as such **TRUSTEES** and the **TRUSTEES** shall be kept harmless and indemnified except for such acts as may amount to fraud and defalcation.







